Conclusion of Presidential and Parliamentary Elections and Preparations for Local Government Councils Elections, 2021

A. Conclusion of Presidential and Parliamentary Elections

The Electoral Commission congratulates the people of Uganda on the exercise of their constitutional rights by participating in the Presidential and Parliamentary Elections held on Thursday 14th January 2021.

The Electoral Commission has declared the winning candidate for the Presidential Elections as well as winning candidates at Parliamentary level.

As you are aware, by law, the results for Presidential Elections must be declared within 48 hours from the closure of polls. The polls closed at 4:00pm on Thursday 14th January and the forty-eight hours expired at 4:00pm on Saturday 16th January 2021.

The provisional results of the Presidential Elections were announced cumulatively in the order in which they were received, leading to a declaration by the Electoral Commission, based on the total number of 33,461 polling stations, which had been duly received and verified before the expiry of the 48 hours, which comprises 96.47% of the total number of polling stations (34,684) across the country.

The declaration met the legal requirement of Section 57(4) of the Presidential Elections Act, which provides that a candidate shall be declared as President if he/she has obtained more than fifty percent (50%) of the valid votes cast at the election.

The candidate who was declared as winner obtained more than 50% of the total votes cast at the election. The Commission considered the fact that the difference between votes obtained by the leading candidate and first runner up would not have a significant effect on the final results even if all the voters from the remaining 1,223 polling stations, who are 694,229 voted for the first runner up.

The Commission will account for all polling stations in due course. A copy of the final tally sheet, with details of district and constituency performance, will be provided to all (former) Presidential candidates, and uploaded on the Electoral Commission website: www.ec.or.ug and published in the Gazette.

The Commission is further finalizing compiling the results of Parliamentary Elections and will publish the results in the Gazette as per the law.

B. Final Preparations for City/District Local Government Councils Elections,

The Electoral Commission appointed <u>Wednesday 20th January 2021</u> as the polling date for Chairpersons, Directly Elected Councilors and Women Councilors for District Local Government Councils (LC V).

The elections for the Lord Mayor, Directly Elected Councilors and Women Councilors for Kampala Capital City Authority (KCCA) and the other ten (10) cities across the country will also be held on the same day.

Voting shall be by universal adult suffrage, and shall take place at all polling stations in the country, beginning at 7:00am till 4:00pm.

Thereafter, counting of votes and declaration of results shall take place.

Political parties and independent candidates are encouraged to have a maximum of two agents at each polling station.

Other than observing the exercise, candidates' agents shall not be expected to interfere with the polling process.

The Commission would like to assure all stakeholders that materials for these elections have been dispatched to the respective districts, and internal distribution is ongoing, to ensure that polling starts on time at all stations across the country.

Voters are urged to turn up in high numbers and exercise their right to vote for leaders of their choice.

All persons participating in the elections shall be required to comply with guidelines issued by the Electoral Commission in accordance with the Government of Uganda and Ministry of Health measures against the spread of COVID-19.

This includes observing social distancing, hand washing, and wearing of masks.
